1. Application of International Tariff

This Tariff contains the rules, regulations and rates for International Long Distance Services offered to Chickasaw Long Distance Company subscribers.

2. Description of Service

Chickasaw Long Distance Company (Company) provides switched message service to international locations described in this tariff. Service is available 24 hours a day, seven days a week.

- 3. Liability of the Company
 - (A) The Company shall be indemnified and held harmless by the Customer against:
 - Claims for libel, slander, infringement of copyright or unauthorized use of any trademark, trade name or service mark arising out of the material transmitted over the Company's facilities; and
 - (2) Claims for patent infringement arising from combining or connecting the Company's facilities with apparatus and systems of the Customer; and
 - (3) All other claims arising out of any act or omission of the Customer in connection with any service provided by the Company.
 - (B) The Company shall be indemnified and held harmless from any and all loss, claims, demands, suits, or other action, whether suffered, made, instituted, or asserted by the Customer or by any other party or persons, for any personal injury to, or death of any person or persons, and for any loss, damage, defacement or destruction of the premises of the Customer or any other property, whether owned by the Customer or others, caused or claimed to have been caused directly or indirectly by the installation, operation, failure to operate, maintenance, removal,

presence, condition, location or use that is not the direct result of the Company's negligence. No agents or employees of other carriers shall be deemed to be agent or employees of the Company.

- (C) The liability of the Company for damages arising out of mistakes, omissions, interruptions, delays, errors or defects in transmission occurring in the course of furnishing service, and not caused by the negligence of the Company, shall in no event exceed an amount equivalent to the proportionate charge to the Customer for the period during which the call was affected. No other liability shall in any case attach to the International Long Distance Service Tariff Company.
- (D) The Company and/or Customer shall not be liable to the other for any failure of performance due to causes beyond its control including fire, flood, epidemic, earthquake, other acts of God, explosion, strike or other labor disputes, riot or civil disturbance, war (whether declared or undeclared) or armed conflict, failure of common carrier or "carrier's carrier" or municipal ordinance, any state or federal law, governmental order or regulation or order of any court or occurrence not within the control of Carrier or Customer, as the case may be.

4. Use of Service

International Long Distance Message Telecommunications Service (LDMTS) may only be used to transmit communications of the customer and authorized users in a manner consistent with the terms of this tariff and the policies and regulations of the Federal Communications Commission (FCC) and local authorities having jurisdiction over the service.

5. Application of Rates

LDMTS is offered on a Direct Distance Dialed basis or an Operator Assisted basis. The measured usage rates for International LDMTS will depend on the time period in which the call is placed, the location to which the call is terminated, and whether the call is direct dialed or Operator Assisted. The rates are charged in increments of an initial rate period of one minute and additional minute rate period. The initial rate period is for connections of one minute or any fraction thereof. Each additional minute is billed on a per minute of use or any fraction thereof that the connection continues beyond the initial rate period. The locations to which LDMTS is available and descriptions of the applicable rates are specified in paragraphs 5(A) through 5(F) following.

(A) CANADA

The measured usage charges are applied as set forth in Paragraph 7 following.

Rate periods are described in paragraph 5(C) following.

(B) CARIBBEAN

The measured usage charges are applied as set forth in International Long Distance Service Tariff Paragraph 7 following. Rate periods are described in paragraph 5(C) following.

- (C) Rate Periods (Applicable to Canada and Caribbean Rates.)
 - (1) Day Rate

8:00 am to 5:00 pm(*) Monday through Friday except for holidays which are billed at the holiday rate specified in paragraph (5)(C)(4) following.

(2) Evening Rate

5:00 pm to 11:00 pm(*) Sunday through Friday, except holidays.

(3) Night/Weekend Rate

11:00 pm to 8:00 am(*) all days, including holidays. 8:00 am to 11:00 pm(*) Saturdays. 8:00 am to 5:00 pm(*) Sundays. (4) Holiday Rate

The applicable rates from 8:00 am to 11:00 pm(*) will be the evening rate schedule and from 11:00 pm to 8:00 am(*) the night rate schedule is applicable.

- (#) If this holiday falls on a Saturday, the Holiday Rate will be effective on the preceding Friday. If the holiday falls on a Sunday, the Holiday Rate will be effective on the following Monday.
- (D) MEXICO

The measured usage charges are applied as set forth in Paragraph 7 following.

(E) Overseas Calling

Locations to which overseas calling service is available are the same as are set forth in Paragraph. The measured usage charges for overseas calling are applied as set forth in Paragraph 7 following. 6. Operator Assisted Calls

The rates for operator assisted international calls handled by the Company include an Operator Service Charge applicable on each billed international message and the measured usage charges. The measured usage charges apply to all Operator Dialed Calls, Customer Dialed or Operator Assisted Credit Card Calls, Station-to-Station Calls, Person-to-Person Calls, and Third Party Billed or Collect Calls. The Operator Assisted Service Charges are applied as set forth as follows.
